I do like to support Ermington where possible but the date change has stymied me. I am chairing a mediation on a highways issue in another Parish tonight and as I am in the chair, it would be difficult to miss.

Report:

1. Director of Public Health at County Hall is urging the 25-50 age band to get boosted. Quote:

The booster, experts tell us, makes a big difference to our immune system.

It's not a 'nice to have', after the first and second jabs. It's as important, if not more so for the additional protection it gives us against getting seriously ill. So please come forward, if you're eligible for the booster and haven't yet had it.

2. The situation regarding the blanket ban on 20mph zones has dramatically altered in the light of a referendum in Newton Abbot where local people voted against their town being used for a year-long trial. As such, County policy is now going to have to be altered and I am hoping that this will allow us to be a bit more pragmatic around speed and signage.

3. Over the next month, we will be meeting at County Hall to agree on next year's budget. I will send a report for Councillors once I know where we are but I imagine balancing the books without some horrid cuts is going to be an exceedingly tricky exercise.

110/21 Drains near the new roundabout at Hollowcombe were blocked which caused flooding during a recent rainfall – the issue has now been dealt with.

110/21 River Erme erosion A3121 - no update from the last parish council meeting.

110/21 Flooding Westlake - tomorrow I am meeting Nick Colton DCC Highways, to arrange a number of site meetings across the Division. I will get 2 or 3 dates to offer to Cllr Creese and will invite parishioner Nick Toms Snr. On the back of the photos sent by Cllr Creese, Nick has fully accepted that there is an urgency in getting this satisfactorily resolved.







110/21 Modbury Cross Woodland Planting - On footpaths, tree planting and bus parking, I am attempting to establish some proactive dialogue between all 3 departments, as discussed at the last PC meeting. Cllr Owens pointed out that the culvert is blocked beside the footpath.

Cllr Thomas agreed to ascertain if he has available funds from grants available to him at Devon County Council, which will be used for the purchase of table and chairs in the lower Reading Rooms.

134/2021 REPORTS ON ALLOCATED AREAS OF RESPONSIBILITY:

a) Churchyard liaison = Cllr Owen has sent an email to the Ermington Parish Church Vicar to obtain confirmation that the church agrees with the plan for disabled access to the Reading Rooms top room to the churchyard. Cllr Onley circulated ideas for the replacement door.

b) Ermington Park = Claire Cross (parishioner) Claire and Cllr Onley have arranged for two picnic benches to be installed in the park, which were paid for by SHDC. RESOLVED Cllr Onley will write an article for the next Ermington Parish Magazine. **ACTION: Cllr Onley**

c) Climate Change and Biodiversity = 30 x 30 initiative from the UK government to protect 30% of the UK's land by 2030. Existing National Parks, Areas of Outstanding Natural Beauty (AONB) and other protected areas already comprise approximately 26% of land in England. An additional 4% – over 400,000 hectares, the size of the Lake District and South Downs national parks combined – will be protected to support the recovery of nature. There is a programme for a catchment river plan but the Environment Agency (EA) seem to say they cannot do continuous testing and therefore we are still not getting test results for the river Erme. RESOLVED Cllr Onley will contact the South Devon AONB. **ACTION: Cllr Onley**

d) Road Warden Scheme update = increase of litter around the parish. RESOLVED Cllr Creese will speak to the parish contact who arranged the litter picking around the parish last year. **ACTION: Cllr Creese**

e) Assessment of Parish footpaths = Cllr Owens – Footpath from Higher Keaton to Fernham - parishioners have enquired why this footpath is not on current OS maps. Cllr Owens circulated a recent email from DCC to parish councillors prior to the meeting in response to getting the footpath reinstated on the definitive footpaths map. RESOLVED Cllr Owens will write an article for the next Ermington Parish Magazine. **ACTION: Cllr Owens**
