It has been reported to D.C.C. Highways the green lane north of Burraton has had branches and other debris left in an unsafe situation. The lane will be closed whilst tree felling takes place to make the lane safe.

A parishioner asked if the lane could be closed for 4x4 vehicles, Cllr Hosking responded it would be difficult to close the lane due to its classification. Cllr Hosking will raise the issue with highways and discuss it further.

154/14 (b) = Following the meeting that had taken place on Monday 23 March 2015 with Cllr T Holway, Mr Nick Murch from South West Water, Mr N Pitts landowner and Cllr T Holway. Cllr Hartwell has drafted a response to S.W.W. which will be copied to D.C.C., and has cireculated it to Councillors. It was agreed the letter was issued – Cllr R Hartwell

Cllr Austin has also enquired to PCSO 30540 A Potter if an illuminated speed alert could be borrowed which will illuminate if the driver is driving faster than the speed limit – Cllr Hartwell
