(a) Police Report for November 2015

(b) Public Questions

A parishioner was aware that a meeting is being held to discuss plans for a village hall on 20 January 2016 and suggested marking out on the playing field the foot print of proposed building. Councillors agreed this was a good idea and would put it forward to the Ermington Village Hall Working Group.

A parishioner pointed out the new drains between Rectory Cottage and Ring of Bells have been successful but no maintenance is being carried. Clerk was asked to contact DCC Highways to ascertain the situation. The parishioner also pointed out that vehicles were parking all day in the lay by the Toll House and asked if there was a possibility for local residents to purchase a "residents only" parking sign to be placed in the area. Clir Kerslake asked the Clerk to clarify the status of the lay by with Clir Hosking and DCC Highways – **ACTION: Clerk.**

A parishioner pointed out the height of hedge near "The Spires" is above stipulated height in the agreed planning application. Cllr Holway to ascertain the situation – **ACTION: Cllr Holway.**

A parishioner asked if signage could be improved to advise large HGV's they could not pass through the village, as an artic lorry has recently been stuck on Bunkers Hill? **ACTION: Clir Hosking to discuss with DCC**

A parishioner pointed out that approaching from Yealmpton at the junction A379 and A3121, the sign is to close to the junction and asked if it could it be repositioned further back near to where there is a "SLOW" sign. Cllr Hosking will speak to DCC Highways – **ACTION: Cllr Hosking.**

(c) <u>District and County Councillor Reports</u>

District Cllr Holway

SHDC was working with adjoining authorities to meet its commitments, including housing needs and would be considering devolution proposals.

Budget setting had started and would be determined on the 11 February 2016.

SHDC agreed to work with surrounding Councils to address planning.

SHDC are introducing a new planning IT system. A parishioner was concern that information in connection with a planning application to be discussed later did not seem to be on the SHDC system. Cllr Holway stated that if parishioners are worried about information being sent to SHDC getting lost to contact him direct.

£500 is still available for local projects, would like ideas by the end of February 2016.

The owners of "The Crooked Spire" are in in discussion with planners at SHDC on the pub's development.

County Councillor Hosking

DCC are doing an additional "Tough Choices Roadshow" to discuss how money could be saved, as there will be a loss of £35 million from the budget which is very difficult to do with statutory obligations. A roadshow is taking place on Wednesday 2 December 2015 at the Watermark in Ivybridge at 6.30pm, all are invited to attend.

Confirmation of the 20 mph signage through the village is being confirmed by Devon County Council Highways.

65/15 MATTERS ARISING

56/15 - erosion of the Erme river bank = an e-mail has been sent to a specialist to obtain a quote for the work, awaiting a reply **– ACTION CIIr Hartwell.**

56/15 - tree causing visibility issues near Endsleigh Garden Centre slip road = Cllr Walsh has arranged for a meeting to take place on Wednesday 2 December 2015 in the area for a contractor to assess the situation and to submit a quote – **ACTION Cllr Walsh.**

56/15 Ermington Primary School crossing Bunkers Hill PV2 assessment = assessment results in a failure of the case as there are an insufficient number of people crossing the road. A parishioner asked if double yellow lines on the turning into Fawns Close could be considered to stop people parking on the area where people cross to enter the school. Cllr Hosking suggested a plan is submitted with details on where the lines should be placed – **ACTION: Cllr Webley.**

56/15 – Playing Field Path = in view of the negotiations which are taking place for Ermington Parish Council to take over the field, the repairs to the path will discussed at the time of the transfer.

56/15 - TAP Fund, defibrillator = the government are offering free defibrillators, training packs and a cabinet. The plan is to site two defibrillators within the village. Cllr Webley is assessing if the telephone box could be purchased and used to house one of the defibrillators. It was agreed two defibrillators will be obtained - ACTION: Cllrs Holliday/Webley.
