County Cllr Hosking reported:-

Cllr Hosking to investigate if there are signs to inform lorry drivers of the weight limit when driving down Godwell Lane towards Ermington to inform them of the 7.5 tonnes weight limit through the village. **ACTION: Cllr Hosking**

Rationalisation of non-emergency 111 service, now to be linked to Devon Doctors system.

Availability of Invest in Devon and Locality funding which must be spent before March 2017.

Broadband - the second phase was going live. To attract alternative Broadband suppliers Devon and Somerset was to be split into six regions.

A379 roadworks - anticipated to be completed by the end of July. The road would be patched and surface dressed on completion.

SHDC have voted that additional money will be used for the next 12 months to assist with clearing the backlog of work.

Locality budget - £700 available for Ermington.

Fusion Leisure would be awarded a 25 year contract to run leisure centres, including investment in the lvybridge centre.
