(a) Police Report for October 2015

(b) <u>Public Questions</u>

A parishioner had met Cllr Hosking and Nick Colton from D.C.C. Highways in the spring but there did not appear to be any progress in connection with drainage on Preston Hill. Cllr Hosking responded that the work required was on the list to be completed by D.C.C. Highways. Cllr Hosking agreed to send correspondence relating to the drainage in that area to the parishioner - **ACTION: Cllr Hosking**

Cllr Midgley pointed out that parishioners would like to help keeping drains clear but there were issues with insurance and liability when working on the highway. Cllr Hosking replied Chapter 8 training had been provided free of charge and DCC has a third party insurance. Those wishing to help are advised to liaise with their own insurance party and show them the DCC insurance.

(b) <u>Public Questions (continued)</u>

Cllr Auburn enquired if DCC Highways operate a system to assess a condition of a road and prioritise what roads and lanes are tarmaced. Keaton Lane had recently been tarmaced wondered why it was deemed necessary on such a minor lane. Cllr Hosking replied it was not his decision but DCC Highways, but he knew the nature of the construction of roads/lanes are assessed prior to work commencing and sometimes the only answer is to invest in a repair rather than patch or surface dress.

Cllr Auburn reported to DCC Highways the three drains from Coyton to Swainage were blocked and asked if the Lengthsman could clear them. Cllr Hosking will arrange for the work will be carried out during December – ACTION: Cllr Hosking.

Parishioner asked why in the last seven years no work has been done on the drainage near his property which had resulted flooding. Cllr Hosking stated that DCC Highways is operating on a smaller budget and to enter the details of this problem on the Devon County Council web site so the problem is placed on schedule of works. The parishioner was also asked to e-mail details of the problem to the Clerk.

A parishioner had recently had a visit by the Mayor of Clecy who would like to resurrect the Twinning and an email had been sent to the Clerk. The Clerk confirmed an e-mail has not been received and asked if the parishioner could forward information to her, this was agreed.

(c) <u>District and County Councillor Reports</u>

District Cllr Holway

- TAP funding – deadline for applications is 12 noon on Friday, 18 December 2015. To enable town and parish councils to set their precepts accordingly, applications will be determined by local DCC and SHDC Members on Thursday, 14 January 2016.

- Speed Check kits – possibility of liaising with Bittaford and Wrangaton to purchase one.

- At a SHDC meeting on Open Spaces, Sport & Recreation is was reported that S.106 funding would be restricted to projects having a close connection with the development site.

County Councillor Hosking

- Tough Choices programme is taking place in the Watermark Centre Ivybridge as £35 million needs to be saved from the budget. Local residents can debate key local issues and have a go at setting their own budget. The meetings are just part of a wider Tough Choices public consultation.

54/15 MEMBERS' CODE OF CONDUCT – Declaration of Interests

In accordance with the Code of Conduct members were invited to declare any personal, disclosable pecuniary or prejudicial interests including the nature and extent of such interests they may have in items to be considered at a council meeting. No such declarations were made.

Cllr Auburn declared an interest in the two planning applications.

55/15 TO CONFIRM MINUTES

The minutes of Ermington Parish Council meeting held on Tuesday 6 October 2015 at 7.30 pm, were confirmed and signed.

56/15 MATTERS ARISING

47/15 - lowering of the speed limit on the A3121 = Cllr Hosking reported that Speed restriction zones are not generally ordered on 'A' roads unless there is a road accident history that supports this action.

The existing 40 mph zone was granted by a Traffic Regulation Order (TRO) despite it not achieving regulation standard for this limit. Seeking to reduce the speed limit to 30 mph would require another TRO and this is not currently supported by road traffic and accident data.

Part of the stretch of road is street lit, but advised that the existing length of street lit road is not sufficient to support a 30 mph limit.

The number of dwellings having access onto the A3121 within this zone is not sufficient to extend the street lighting, despite two exit roads serving Ermington and the lvybridge link road.

DCC Highways are looking at ways in which we can potentially improve the visibility at the Town Hill junction including the suggestion of a pavement around the Toll House moving the traffic away from the northern road edge.

DCC Highway are currently investigating the possibility of confirming the 20 mph zone through the village supported by additional roundel markings which should enable voluntary speed checks.

47/15 - erosion of the Erme river bank = Cllr Hosking reported that the advice from the County Solicitor is the maintenance of the river bank is the responsibility of the riparian landowner. In the light of this advice the County Council will not prepare a report on the possible contributory responsibility of South West Water through undermining of the river bank when relocating their sewerage pipe. Cllr Hosking has sympathy with the landowner in this situation. He will support the landowner as far as he can in securing grant funding to facilitate a timely repair. In the light of the advice above, it is unlikely that DCC will offer any funding. He will enquire in the first instance whether any financial support can be obtained by the Landowner through Countryside Stewardship for the straightening of the river or maintenance of the riverbank. Cllr Hosking has been advised that land owner has been in contact with David Whitton of Devon County Council and is currently investigating the extent of his title through searches.

Cllr Kerslake said that the danger of road collapse and high cost of repair could be avoided with a pragmatic approach now. The Parish Council would continue to pursue the case for action. In the meantime it would try to follow up a previous contact with a specialist who had indicated the possibility of a free quotation to provide a solution to the problem – **ACTION: Cllr Hartwell.**

47/15 - costing on a replacement sign request for a parishioner = Cllr Hosking and Nick Colton DCC Highways tried to find the sign in question at West Worthele without success. The short answer to your question is about £45.00 assuming it simply requires straightening. Nick Colton advises that he made enquiries and was advised of a bent sign at Modbury Cross on the A379 which has now been straightened.

47/15 - assessment of the splay at the entrance to "The Spires" = the speed hump has been relocated. Cllr Hosking assumed that the "road narrows" sign pre-dated the traffic speed zone relocation. It is considered superfluous and Nick Colton advises it may have been removed by the contractors constructing the road hump. The contractors removing the speed hump have also agreed to patch the surface of the junction with "The Spires" development.

47/15 - tree causing visibility issues near Endsleigh Garden Centre slip road = the Local Highways Operations Manager has inspected this slipway at the request of the Parish Council and his assessment was that the visibility is adequate. In the light of objection by Ermington Parish Council he has asked a colleague to inspect, who came to the same conclusion. Cllrs Auburn, Martin and Walsh stressed there was a blind spot at this junction. It was agreed that Cllr Walsh will liaise with the owner of the field to ascertain if the trees can be removed and prepare a response to Cllr Hosking highlighting the need for the trees to be removed – **ACTION: Cllr Walsh.**

56/15 MATTERS ARISING (continued)

- 49/15 Ermington Primary School crossing Bunkers Hill PV2 assessment = Cllr Hosking had contacted DCC Highways and a PV2 assessment will be carried out in the area - ACTION: Cllr Hosking/DCC Highways.

47/15 – one way system in the area at the junction of A379 and A3121 = the available accident data for Hollowcombe Cross to 31 December 2014 does not support any changes to the junction. However, we will wait for the data to 31 December 2015 before commenting further on this proposal. The suggested solution if supported by accident data is to make the stretch of road from Hollowcombe cross to the crossroad eastbound only, rather than a roundabout as shown on historic plans which were forwarded with your recent correspondence.

34/15 – Playing Field Path = clarification on repairs required on the foot path around the playing field is still being pursued - **ACTION: Clir Holway.**

34/15 - TAP Fund, defibrillator = ClIrs Webley and Holliday had looked into the purchase of, siting, training and maintenance of a defibrillator. ClIr Webley stated it would cost £1800 to site defibrillator and this includes the replacement of pads when the machine is used. ClIr Holliday had looked at independent companies and the average purchase price is £1200 and Philips is recommended. No maintenance cost and the battery life is 5 years, currently a replacement battery would cost £45. BT would the sell the phone box if the decision is made to locate the defibrillator there. The pads supplied with defibrillator last 18 months. A person would need to be assigned to check the defibrillator. After the initial outlay there would be minimum cost to run it. ClIr Holliday will assess the training costs. **ACTION: ClIr Holliday.**

It was agreed to purchase the defibrillator independently.
