Cllr Denis Onley welcomed everyone to the meeting and introduced Cllr Ian Creese, who confirmed he had completed the Declaration of Acceptance of Office prior to the meeting.

The night shift cannot guarantee to be available in the Ermington area around the problem times.

Cllr Onley wished it to be noted the night/early morning weekday motorcyclist has stopped riding through the village, but there is still an issue with motorbike noise at weekends. Especially during fine weather on Saturday and Sunday mornings and Sunday afternoons.

The motorcycles are often in groups and so when they have modified the exhaust pipes to make maximum noise, they make a lot of noise, which you can hear all along the valley.

No one wants to stop responsible motorcyclists enjoying a ride, but there are clearly some that think they can have their fun without caring about the impact on local residents, so a weekend patrol along the A3121 between Wrangaton & Modbury Cross, or A379 between Ermington & Yealmpton would be much appreciated.

117/19 REPORT FROM DEVON COUNTY COUNCILLOR RICHARD HOSKING, INCLUDING OUTSTANDING ITEMS FROM PAST MEETINGS:

101/19 Flooding from highways water run-off at "The First and Last Bistro" car park. Awaiting the outcome of work being carried out by South West Water (SWW) to ascertain if it will resolve the problem. Cllr Hosking will liaise with SWW for an update on the situation. **ACTION: Cllr Hosking**

101/19 Blocked drains on the left-hand side of Town Hill and Chapel Street. Grate to be removed to assess the situation. Ongoing

101/19 River Erme erosion A3121 - aerial survey is due, when completed an assessment of movement of riverbank will be confirmed. **Ongoing**

101/19 Playing field application to be a Village Green. Cllr Hosking has made an enquiry to the Devon County Council Solicitor and she has not made a decision. **Ongoing**

101/19 Flooding Westlake – being assessed by Cllr Hosking & DCC Highways. Cllr Creese pointed out he had recently contacted DCC Highways but has not received a satisfactory answer. A site meeting to be arranged to assess the problem. **ACTION: Cllr Hosking**

103/19 Drainage work on the road from Ermington to Sheepham is not effective when it rains. Cllr Hosking to discuss with Nick Colton DCC Highways. **Ongoing**

119/19 QUESTIONS AND COMMENTS FROM MEMBERS OF THE PUBLIC TO THE PARISH COUNCIL, COUNTY & DISTRICT COUNCILLORS AND POLICE (A PERIOD OF NOT MORE THAN 15 MINUTES)

A parishioner explained to make a Community Shop room larger, there is a need for a disabled access ramp. Cllr Holway suggested the £400 grant from the Locality Fund is used towards the ramp.

Cllr Walding enquired when planning application 3354/19/FUL - proposed installation of a Peaking Gas Generation Plant with associated development to include vehicular access and security fencing, Ermington Road", Ivybridge, will be discussed at South Hams District Council. Cllr Holway stated that the planning application will be discussed at the Development Management Committee on 15th January 2020, and the meeting is due to start at 11 am. Cllr Onley reminded Cllr Holway that Ermington Parish Council had objected to the application.

A parishioner put forward the reason for their full planning application - Reference: 3912/19/FUL, The Workshop, Cowsberry Farm, Burraton Cross to Luson, Burraton, PL21 9JZ.

Cllr Allis raised the issue of the outside light at Ermington House. The light is very bright and a safety issue to those driving towards the building from the Ugborough direction. ACTION: Cllr Hosking

A parishioner raised concern about the cost for a community shop coffee machine and was referred to by a Councillor to "Ermington Shop & More" public meetings, where the equipment details would be decided.

BUDGET 2020/2021 – A draft budget (see attached) had been forward to Councillors prior to the parish council meeting. It is predicted a general expenditure circa £19,000.

PRECEPT 2020/2021 - Three options were put forward:

- 1) Continue with the same Precept as currently charged.
- 2) Reduce the current Precept by 10%, to reflect the lack of progress with the previous Village Hall plan over the last 2 years therefore returning the last 2 years increases in Precept to parishioners.
- 3) Reduce the Precept by 25% to balance income with normal expenditure, and take any one-off grants, for example, those currently under consideration to, Devon Air Ambulance and "Ermington Store & More" project and more projects from the Parish Council £80K reserves.

Agreed to reduce the current Precept of £27,000 by 10% to £24,300. ACTION: Clerk

125/19 REPORTS ON ALLOCATED AREAS OF RESPONSIBILITY

- a) Churchyard Committee no meetings have recently taken place. Cllr Dunlop
- b) Footpath from Higher Keaton to Fernham to be reinstated. Survey of footpaths to be carried out CIIr Walding
- c) Ermington Park tree planting & play equipment Cllr Cross
- d) Ermington Store & More Cllr's Allis & Dunlop

Cllr Onley – a £5,000 grant request has been received or an alternative request to purchase a coffee/tea making machine. Currently the project is not a registered charity and is currently managed by the Directors rather than as a democratic community business.

Grant requests have been made by the committee and work has commenced in the building. The plan is open the Ermington Store & More in February 2020, but it may not be fully completed. A limited Company has been set up. An application is with the Plunket Foundation. There will be shares available, one member one vote, maximum and minimum target not decided until advice has been received from the Plunket Foundation.

There is a committee who will ascertain what stock will be required in the shop.

The Directors are Andrew Savery, Alistair Hurst, Matt Woolcock, Nicky Scutt and Jill Bleiker.

Standing orders were suspended.

Parishioner asked if the furniture within the Reading Rooms will be moved to the Ermington Store & More building. Cllr Onley stated that no request had been received and so there is no plan to move items. The Parish Council meetings will move to a room within the Ermington Store & More building, which will ensure access is available to all parishioners etc.

Standing orders were reinstated

Cllr Dunlop proposed bookings for Parish Council meetings over the next 10 years to the sum of £3,600, could be paid upfront and used to buy the coffee/tea making machine. Cllr Onley suggested Councillors consider the proposal, as then it would mean the Parish Council would be supporting the project by moving the Parish Council meetings to the hub within the Ermington Store & More building for ten years and have a voting right which would be nominated to a Parish Councillor.

It was agreed £3,600 would be released when the Directors had set up a Community Benefit Society and Governing Documents including the Membership Strategy documents. Also, one Corporate Share provided to the Parish Council and that the £3,600 would cover the hire of the hub in "Ermington Store & More" building for the next ten years for Parish Council meetings.

e) Village events: Ermington Village Walk 28/12/2019 was very successful with 22 people in attendance. The Wassail which took place on 05/01/2020 was also very successful and the Parish Councillors wished to extend their thanks to the parishioners who hosted the event.

126/19 DCC HIGHWAYS A3121 WORKS

Devon County Council are in discussion with residents regarding the Parish Council's suggestion to extend the footway further eastwards towards Ermington House. DCC have provisionally booked road space for these schemes, between February – April 2020.

Site 12 Modbury cross land negotiations taking place – final scheme plan now ready for Stage 2 safety audit and will be sent off in the next few days.

Site 6 Ware Cross we intend to carryout out the works during the time that the road is closed for the culvert works (24 February – 13 March 2020) using the same contractor.

Site 4 Kitterford Cross – safety audits – these were stage 1 audits based on a two dimensional preliminary designs, the purpose of which is to flush out any "show stoppers" for a scheme before the detailed design commences. The audits highlighted the problems associated with each option namely the summit prior to the junction and speed transfer from one through route to another.

There will be disruption when the work commences as patching will also be taking place. An area of inlay patching is also planned west of the Town Hill junction.
