# 131/19 REPORT FROM DEVON COUNTY COUNCILLOR RICHARD HOSKING, INCLUDING OUTSTANDING ITEMS FROM PAST MEETINGS

#### 136/19 FLOODING/DRAINS AT "THE FIRST AND LAST BISTRO"

Cllr Cross explained the flooding issues is having an impact on the owners of the business. The lower part of the drain is being addressed by South West Water.

Standing order suspended

Owner of the property explained how South West Water are dealing with the flooding problem. They also pointed out the pipe at the top of the hill was replaced a few years ago from a smaller pipe to a larger drainage pipe. South West Water will commence work on 10 February 2020.

They have also requested information on recent planning application that have been approved in the vicinity of their property as this has caused additional run off.

Cllr Hosking will speak to Nick Colton DCC Highways in connection with replacing the pipe in the highway near the property.

Dear Council Representatives,

Firstly, can I apologise for the length of time it has taken for me to write to you and provide an update on the ongoing relationship you will have with us moving forwards.

I understand that your council has had representation by the Police, either in person or in the form of written report, for many years. At one time this is likely to have been from an Inspector or Sergeant, then to a PC and now more likely a PCSO.

We will no longer be routinely attending any Council meetings or completing written reports. This change is not isolated to the lyybridge and West South Hams sector and has been in place in other sectors across the Devon and Cornwall Police area for some time.

This does not mean that we do not want to hear from you, to speak with or work with you. We completely recognise that you are one of the key conduits between the community and the Police, but this working relationship needs to evolve and grow for the benefit of the whole community. If there is an issue that the community raises to you, tell us, call us, email us and we will assist in any way that we are able. We will continue to maintain contact with you particularly if there are specific community related policing issues that you need to be aware of.

We are constantly seeking to improve and adapt the way in which we connect and engage with our communities. Information relating to crimes and incidents, previously given in the form of reports, is readily available from www.police.uk and also through the Councillor Advocate scheme.

The councillor advocate scheme is operating within the Devon and Cornwall Police area and provides an opportunity for parish, town and district Council representatives to volunteer, becoming the 'single point of contact' between their councils, the Police and the Police and Crime Commissioner.
