Cllr Kerslake had circulated a budget and explanatory note to councillors which had been drafted following a meeting of the Finance Sub-Committee.

Councillors discussed the recommendation from the Finance Sub-Committee that the current precept be increased by £3000 to £24500. This would require a parish rate for a Band D property of £64.62 per year representing an increase of £8.29 per year or, 16p per week. Parish and town council precepts will not be subject to referenda. Taking these factors into account and the desirability of building up a fund to help finance the construction of a new village hall, the Finance Sub-Committee view was that it would be prudent to increase the Precept as recommended.

A vote was taken. 6 Councillors were in favour of accepting the recommendation. 1 Councillor objected supporting a 5% increase only. An increase of £3000 was therefore agreed.

The Clerk reported that two parishioners had contacted her to explain the urgency of the need to clean the culvert under the A3121. Nick Colton (Devon Highways) had been contacted and is making arrangements for an external contractor to come with a large jetter to shift the silt.

Cllr Hartwell asked Cllr Hosking if there were any plans for a Civil Enforcement Officer to enforce the restrictions now that the double yellow lines are in situ near Fawns Close. Cllr Hosking advised Nick Colton (Devon Highways) be contacted to deal with the matter.

Cllr Webley asked if Devon Highways could assess the flooding and condition of the road surface on the road from Keaton to Ermington as it is in poor repair. Cllr Hosking will report the issue to Nick Colton (Devon Highways). **ACTION:**

(c) <u>District and County Councillor Reports</u>

County Councillor Hoskina:-

Pothole fund has been allocated again for this year – report of potholes in the parish was requested using the Devon County Council website.

The school funding allocation reassessment had resulted in a greater allocation per pupil in smaller schools. DCC would be making representations that the overall funding levels were still too low in relation to the rest of the country

£22m reduction in central government support funding, a 4.99% increase in Council Tax is proposed. There will be a need for Parish Councils to take on additional responsibilities.

District Councillor Holway reported:-

SHDC & West Devon DC had decided not to form a Local Authority Controlled Company

The Joint Local Plan was progressing to final consultation. Development was concentrated in Plymouth, with no targets for villages.

TAP funding for the lawn mower has been agreed with a suggestion that it be stored in Ermington. Cllr Kerslake suggested liaising with the cricket club and it was agreed that the club should take ownership of the machine.

Nick Colton (Devon Highways) is meeting local parishioners in connection with flooding issues near Fawns Farm, Ermington.

(d) <u>Lee Mill Solar Roof Project - Sophie Phillips, South Dartmoor Community Energy (SDCE)</u>

Sophie Phillips gave a ten minute presentation on the purpose of the not for profit organisation which grew out of the PL21 group.

Sophie explained that SDCE was a community benefit society helping local communities to become more energy efficient and involved in renewable energy projects. Part of the national Big Energy Saving Network and available to give householders help and information about saving energy, changing tariffs to minimise costs and even applying for grants. All the advice is free and impartial and can include home visits if necessary. Help is focussed on supporting people who have not switched suppliers before, who lack internet access, who have health issues or low incomes and will include practical support to help people reduce their bills. This can include advice on choosing the best energy tariff, help with switching supplier, information about smart meters and details of energy efficiency offers.

SDCE was awarded a grant from the Rural Community Energy Fund to carry out a feasibility study to look at the potential for community owned solar PV on some of the roofs at Lee Mill Industrial Estate at no cost to the companies.
