# Cllr Hosking -Devon County Council – emailed the following:-

Note on First & Last. A meeting was arranged to inspect the property and investigate flooding issues. I have subsequently consulted the County Solicitor who is investigating the legal issues and who will report back. Andrew Savery has kindly obtained a quote for drainage works to remove the problem from the front entrance porch and I am grateful for his help in this respect.

## Cllr Holway - South Hams District Council

Has enjoyed his time as District Councillor and will be running for re-election. Cllr Kerslake thanked Cllr Holway on behalf of the Councillors for his help and advice.

#### 120/18 ERMINGTON VILLAGE HALL PROJECT (EVHP) - CIIr Kerslake

A situation report had been prepared by Cllr Kerslake providing background, potential barriers to the project and suggestions for a way forward. A report had also been prepared by the Chair of the Village Hall Working Group who provided the meeting with an outline of its content. Both reports are attached to these minutes.

Cllr Kerslake emphasised the need for the post election council to have a discussion with Working Group which had indicated its belief in the need for a new village hall and its desire to engage with the new council to debate the issues involved.

# 121/18 PLAYING FIELD BENCHES - Clir Onley

Cllr Onley said that the money provided from Cllr Holway's locality fund would cover the cost of buying and installing two benches but that his original plan was to provide one bench and one picnic table which would be more expensive and have implications for the overall cost when installation costs were added. The use of volunteers for installation would overcome this difficulty and Cllr Onley will look at this possibility.

Cllr Kerslake expressed his view that installation costs should not be sought from parish council funds and that the project costs should be kept within the amount requested from the locality fund. Cllr Onley said that he would discuss the various options with the Village Fund as it has experience of providing new seating in the Park. Clarification was also required regarding ownership of the seating if the application had been made on behalf of the Friends of Ermington Park Group. **ACTION: Cllr Onley**
