(c) Public Questions

Parishioner – Mr Holliday raised the question of management of the Public Open Space below "The Spires" development. Cllr Kerslake emphasised that the Parish Council had been invited to take on the land under the Section 106 agreement but had declined the invitation after careful consideration of the maintenance costs and liabilities which would arise in perpetuity. The Parish Council said that it was happy to support Mr Holliday's endeavours to look at alternative arrangements for taking over the management of the land involving local residents and Mr Holliday agreed to pursue this with the assistance of Cllr Holway, Mr Sekula (SHDC/West Devon), Mr Toms and BDW (The Developer). **ACTION: Mr Holliday**

Parishioner – disappointed there has been no contact during the last 4 months in connection with flooding at his property, "The First and Last". Cllr Hosking was given the parishioner's contact details to arrange a meeting. **ACTION: Cllr Hosking**

Parishioner – alterations to Ermington/ Ivybridge road near Endsleigh Garden Centre. Asked whether Devon County Council could look into the footpath being upgraded to accommodate new regulations as it has continuous use. In addition, suggested it was an excellent time to adjust the bend where cars were not able to see those approaching at the junction near Endsleigh Garden Centre. Cllr Hosking will assess. **ACTION: Cllr Hosking**

Parishioner – asked if Devon County Council and the Local Education Authority had given consideration to local schools including Ermington and Ivybridge who might be directed to Sherford schools. The parishioner was hoping that the Parish Council would ask for details of any plans and the timescale involved. Cllr Hosking explained that Sherford has now built its first school and there are more to follow, but a secondary school is not planned yet. Cllr Hosking pointed out that the County consider the number of pupils in a given year and look at the catchment area. Cllr Hosking agreed to ask for an update of the situation. **ACTION: Cllr Hosking**

Parishioner (Mr Holliday) – enquired if the church could apply for grants as the bells require repair work. Cllr Hosking will enquire. **ACTION: Cllr Hosking**

90/18 Brightness of exterior light at Ermington House. ACTION: Cllr Hosking

90/18 Flooding from highways water run-off "The First and Last Bistro" car park. Meeting to be arranged. ACTION: CIIr Hosking

92/18 River Erme erosion A3121 - aerial survey is due this year, when completed an assessment of movement of the riverbank will be confirmed. **ACTION: Clir Hosking**

92/18 Reading Rooms - various items have been removed. ACTION: Cllr Onley

92/18 Ermington parish spring clean day update. Cllr Martin asked Cllr Hosking how waste from the spring clean day on 14 April 2019 can be dealt with. Cllr Hosking will seek clarification, also Cllr Holway. **ACTION: Cllr Hosking/Holway**

104/18 CONDITION OF ROAD TO SHEEPHAM FROM THE A131 AT STRODE CROSS TO CROWNHILL CROSS

Some drainage works below Crownhill Cross have recently been completed and also some minor patching in the immediate area. All potholes that meet the criteria for a defect are repaired to specification but admittedly the water run-off is not helping. DCC Highways had done all that can be done to try and remedy the run-off but the area is constructed on bedrock leaving little room for drainage system improvements. DCC Highways has arranged for the system to be cleared whenever it has been possible, in addition to the programmed annual clean.

To place an "unsuitable for HGVs" sign is deemed unnecessary and would be difficult to provide in the current climate, especially as a lot of the larger vehicles are accessing local farms. However, as the parish boundary ends at Crownhill Cross, Nick Colton DCC Highways will speak with his opposite number who looks after Modbury to see if he has any views on the issues raised.

105/18 ALLOTMENTS - CIIr Onley

The owner of land within the village who had been approached does not wish to sell, lease or rent.

The Clerk has been in contact with the owner of a piece of land who wished to explore the idea of their land being used for allotments. It was agreed that the Clerk will pass Cllr Onley's telephone details to them. **ACTION: Clerk**

106/18 ERMINGTON VILLAGE HALL PROJECT (EVHP) - CIIr Kerslake

Cllr Kerslake explained that Devon County Council (DCC) solicitor had decided to seek the opinion of a Barrister who is an expert in the field of town and village greens. This meant that the project was, in effect, on hold. Cllr Kerslake hoped to bring more substantial information to the next meeting.

107/18 FELLING OF TREES ON THE BOUNDARY BETWEEN THE INDUSTRIAL ESTATE AND POS BELOW THE SPIRES – Clir Dunlop

Cllr Dunlop pointed out the trees which were not to be felled past the first unit have been removed. This is extremely disappointing, as the Council was assured the industrial units would remain screened. Light pollution from the MOT centre is now visible across the playing field, and in addition two floodlights are also clearly visible, which is not necessary. Cllr Holway will assess the situation. **ACTION: Cllr Holway**

108/18 PLAYING FIELD BENCH - CIIr Onley

Two plastic benches could be purchased with the £500 Locality Fund grant received from Cllr T Holway. Cllr Hosking also agreed to provide a grant towards the cost of installing the benches. Cllr Onley to liaise with Cllr Webley on where the benches will be placed. **ACTION: Cllr Onley**
