178/2020 REPORT FROM DEVON COUNTY COUNCILLOR RICHARD HOSKING, INCLUDING OUTSTANDING ITEMS FROM PAST MEETINGS

Cllr Hosking has received correspondence and photos in connection with concerns of a recently installed gas supply at 2 Park Hill Cottages, Chapel Street, Ermington PL21 9NF. The supply pipe has been attached to the outside of a high wall directly above the road surface where the highway is narrowing to around 3 meters. The pipe is proud of the wall, in a Conservation Area and regularly used by large agricultural machinery.

Cllr Hosking has been asked if a written response could be given to the Parish Council from Devon County Council Highways, stating that a planning application was not required and it is not a serious hazard and meets all Highways Safety requirements, together with general Health and Safety requirements for neighbouring residents.

159/20 Blocked drains on the left-hand side of Town Hill and Chapel Street, grate needs to be removed to assess the Situation – Cllr Hosking

Cllr Onley - The Erme Bridge (Site 8) to Ermington Woods's footway, the Parish Council is waiting for information on whether the preferred option C is still an option, or it has been ruled out due to cost.

The verge (Site 10) area of land Richard Kingsley-Smith, Devon County Council is refers to in his correspondence is required for a new footway to the bridle-path is between Rectory Cottages and Ring O' Bells Cottage. It is not known who owns this land, a photo of the area will be sent to Cllr Hosking by Cllr Onley to ascertain ownership.

The Parish Council needs to understand Option C for Ermington House scheme. Cllr Hosking will liaise with Richard Kingsley Smith, Devon County Council.

179/2020 REPORT FROM DISTRICT COUNCILLOR TOM HOLWAY, INCLUDING OUTSTANDING ITEMS FROM PAST MEETINGS

SHDC – agreed to provide extra locality money for environmental projects, which equates to £1,000 per annum. Also assessing regeneration on a match funding project. Please liaise with Cllr Holway if you need any advice.

Fusion – out door classes commence on 12 April 2021. Outdoor group exercise classes will continue at lyybridge Leisure Centre and Meadowlands Leisure Centre, until indoor classes are permitted from 17 May.

Up to £600k has been set aside to support business recovery in the South Hams.

Following persistent lobbying by SHDC and other councils, the government is closing the loophole that allowed owners of holiday homes to avoid paying council tax and to receive Covid grants in excess of £11 million.

SHDC is working with Devon County Council for active travel and reducing bad air quality.

Charges for open spaces will remain the same.

If the Ermington Fair takes place, the cost of hiring the playing field will be absorbed by Cllr Holway/SHDC.

180/2020 PUBLIC OPEN FORUM - Questions and Comments from Members of the Public to Parish Councillors, County and District Councillors

Cllr Onley thanked Devon County Council for installing a gate on the footpath near Sequers Bridge

Cllr Onley – would it be possible to have road signs warning motorists of hedgehogs in the area drive and to drive with care. Cllr Hosking pointed out the signs must be authorised by the Department of Transport, and in order for them to consider the request the parish council must provide:

- Maps showing the approximate locations where the signs are to be placed
- Evidence showing that the locations are accident and wildlife hotspots.

Parishioners to provide evidence to Cllr Hosking of the locations of widlife accidents, which can then be reviewed in order to make an application to the Department for Transport. If authorised, signs can be erected at safe locations when funding becomes available.

181/2020 IDEAS TO REDUCE SPEED OF VEHICLES/ TRAFFIC CALMING AND PEDESTRIAN SAFETY THROUGH THE VILLAGE:

- 20 mph speed limit road signs for the village **CIIrs Yates** signs are now in situ within the village. The highway speed limit sign in the hedge near Ermington Primary school is not visible. Resolved CIIr Cross will liaise with the Primary School, asking if the hedge could be trimmed. **ACTION: CIIr Cross**
- Ermington Primary School to be asked to design "20 mph is plenty" signs Clir Cross Resolved not to pursue this idea, as no response has been received from the Primary School
- Flashing speed sign near the Ermington Store and More Cllr Creese Cllr Creese will send details of the speed sign manufacture to Nick Colton at DCC Highways. ACTION: Cllr Creese

Cllr Owens pointed out, currently there is poor access to Reading Rooms. If the Fire Exit in the top room was made larger it could be used for disability access. Could the steps be covered and a disabled access lift installed between the floors? Resolved Cllr Owens will liaise with Ermington Parish Church. **ACTION: Cllr Owens**
