Public Questions

Cllr Onley has asked SHDC for details of the maintenance of the hedge boundaries around the playing field. The owners of Valley Lodge would like to ensure the top of the hedge is cut, as well as the sides and the hedge spills over the wall into the road along Bunkers Hill and A3121. ACTION: CIIr Holway

Cllr Onley asked if SHDC could liaise with the cricket club, to make sure the field is cut to the required length before matches during the playing season. ACTION: Cllr Holway

Cllr Owens asked if SHDC were looking at simplifying the waste recycling collections. Cllr Holway confirmed SHDC are reviewing the waste collection.

Supporting Devon Residents into Homes of their Own

Very happy to report that Cabinet are recommending support of the motion and have agreed that County will lobby our local MPs to strengthen the criteria for properties becoming liable for business rates, instead of council tax. This would avoid the huge amounts of business grants paid out over COVID in Devon.

COP 26

A motion has gone to Cabinet asking Council to support the following:

[DCC] will work with Government and local Government networks, to make sure the COP26 text is translated into meaningful local and national programmes to reduce carbon which are supported by agreed and sufficient funding by Government.

Divestment of Fossil Fuels

DCC has received numerous communications from Devon residents (including this Division) asking County to divest its pension fund stakes immediately. Regrettably, the administration has voted this down and for now, the various pension funds will continue to profit from fossil fuels. There is a commitment not to make new investments, but I know many residents will be extremely concerned. I will continue to vote against the status quo when I can.

Defibrillator at Penquit

Happy to have offered support for this project to the tune of £700.

080/21 Make the footpath safer from opposite Plantation House to the bus stop near Sequers Bridge - RESOLVED a meeting to be arranged with Emily Spurway and Paul McFadden, Public Rights of Way, Devon County Council to discuss the condition of the footpath.

080/21 Drains near the new roundabout at Hollowcombe were blocked which caused flooding during a recent rainfall - *Cllr Denis* Onley has had a lengthy email from Richard Kingsley Smith at Devon County Council and Cllr Thomas has spoken to Nick Colton, DCC Highways, who has spoken to the design engineer too.

005/21 River Erme erosion A3121 – Nick Colton, DCC Highways has assured Cllr Thomas that while there are no answers yet, he is aware of a regular string of internal emails being sent.

005/21 Flooding Westlake – RESOLVED a meeting to be arranged with Cllr Creese and Cllr Thomas to attend a new meeting to kick start matters.

005/21 Modbury Cross Woodland Planting - Cllr Thomas has sent a copy of DCC planting to the Parish Council. Planting to start in March 2022.

Report from District Councillor Tom Holway:

SHDC are attempting to recruit planning staff.

There are schemes across wards to combat Climate Change and Biodiversity, which may benefit this ward.

"Better Lives for All" consultation - no issues were raised.

SHDC will be increasing the Council Tax.

SHDC supported the removal of business rates from holiday accommodation.

112/2021 PARISH CHURCH, PARISH COUNCIL AND THE COMMUNITY – David Sayle - Rector of The Three Rivers Mission Community

Rev David Sayle has been in situ for six years covering seven local parishes. The church would like to improve connection with the community. Would like to work together for the parish in future events e.g. Queens Platinum Jubilee. There is the parish church, village shop, hub and Village Fund, how could these organisations work together for the community?

Discussion ensued on how the Reading Rooms could be made accessible from the church. It was pointed out that the Diocese would need to be consulted on any plans. RESOLVED Cllr Owen to obtain confirmation that the Diocese is in agreement with the necessary churchyard alteration. This will enable the top room of the Reading Rooms, to be made disabled friendly from the churchyard. **ACTION: Cllr Owens**

Cllr Onley stressed, if the Parish Council were to create disabled access path to the Reading Rooms via the churchyard, there would need to work closely with the church and to ensure parishioners are aware of costs which may be covered by grants.

The flashing speed sign near Ermington Store and More is now working.

Mobile speed camera – RESOLVED Cllr Creese to liaise with Cllr Holway to obtain the camera. ACTION: Cllrs Creese/Holway

Reading Rooms, lower room - heating now installed, new fire extinguishes in situ. Toilet and kitchen units to be installed.

Reading Rooms key pad lock number has been changed by Cllr Creese as requested by Councillors.

119/2021 REPORTS ON ALLOCATED AREAS OF RESPONSIBILITY:

a) Churchyard liaison = RESOLVED Cllr Owen to obtain clarification from the church on the plan for disabled access to the Reading Rooms top room to the churchyard. RESOLVED Cllr Onley will obtain ideas for the replacement door. **ACTION: Cllr Onley**

b) Ermington Park = Claire Cross (parishioner)

c) Climate Change and Biodiversity = Cllr Onley – Mark Walker (parishioner) has agreed to be the River Warden. There is a 'virtual' meeting with the ANOB to look at the River Catchment Management Plan which he will attend.

d) Road Warden Scheme update = Cllr Creese – attempted to attend a Devon County Council Highway online meeting, but the internet connection was poor.

Cllr Onley reported on communications he has had with DCC and the landowner of the field below the A3121 by Bunkers Hill. A leat is piped under the field and DCC Highways are responsible for its maintenance, the landowner believes the pipe is blocked or broken, causing flooding to the field, and this is backing up the drains onto the A3121, causing regular flooding of the road. DCC have cleared leaves from the gully and are arranging to camera survey the drains.

Cllr Creese has cleared leaves and detritus from a number of drains and shared photographs (see below) of flooding at Westlake which has been reported to DCC.

e) Assessment of Parish footpaths = Cllr Owens – Footpath from Higher Keaton to Fernham - parishioners have enquired why this footpath is not on current OS maps. Cllr Owens is liaising with DCC to get the footpath reinstated on the definitive footpaths map.
