047/2022 REPORT FROM DEVON COUNTY COUNCILLOR DAN THOMAS INCLUDING ITEMS FROM PAST MEETINGS

Cllr Hart, Conservative Leader of DCC, has unilaterally decided to suspend county locality payments in the face of the Council's budgetary difficulties. Cllr Thomas thinks this is wrong and totally against the Corporate Strategy aim to help Communities to remain strong, connected and resilient.

River Erme erosion A3121 and public footpath gate entrance opposite Plantation House – no further information available. Cllr Thomas has asked DCC if the footpath gate entrance could be sensitively pruned.

Potholes in Westlake and Luson and flooding in Westlake – Cllr Thomas has sent a formal letter to the landowner, but to date no response has been received. RESOLVED Cllr Creese and in agreement with a parishioner, will liaise with the landowner

Planting and works to DCC land adjacent to A3121 - trees are being planted in November 2022

DCC Review of Bus services to Ermington and response from Sir Gary Street MP – mixed messages from DCC which Cllr Thomas is attempting to clarify

Locality Money payment – Cllr Thomas explained the application for a grant towards the recently purchased chairs in the lower Reading Rooms, was not successful. As the chairs were purchased prior to the grant application.

SHDC have withheld money to the current waste contractor as bins have been missed, this is why parishioners are asked to report any waste collections that have not taken place.

Parishioner asked if anything is happening with assessing the company "Fusion" who look after the leisure centres. As there has been adverse comments about their operation of leisure centres in the media? Cllr Holway was not aware of anything specific.

Parishioner asked why Modbury Lane had been closed for three weeks. RESOLVED Cllr Thomas will investigate.

Parishioner asked why the Reading Rooms toilet had a key entry lock, as he understood it was part of public toilets. Cllr Onley was not aware of the Reading Toilets being public toilets. RESOLVED the toilets to be opened. **ACTION: Cllr Creese**

Cllr Dunlop asked Cllr Holway if the waste collection vehicles could be asked to slow down on their route from Ivybridge to Ermington. RESOLVED Cllr Holway to action. **ACTION: Cllr Holway**

Cllr Onley pointed out, the recently revised Ivybridge Erme Court car parking system is causing confusion, as although two hours parking remains free, parking for longer is now chargeable 24/7, parishioners attending evening events at the Watermark are therefore advised to park in the SHDC Leonard's Road car park, as it remains free after 6pm. Cllr Holway pointed out the Erme Court carpark is not operated by SHDC.

Ermington Parish Magazine - to contribute to production costs - RESOLVED to grant £1,000. ACTION

Ermington Village Fund - to contribute funding towards the parish jubilee firework display, on bonfire night 2022.

Standing Orders Suspended at 8.00 pm

Representatives from Ermington Village Fund explained the reason for the grant and questions were asked by Parish Councillors. The cost of the fireworks is £2,250, and the Village Fund are seeking a contribution of £750 - £1000 towards this in case the event receipts fail to cover the cost. Entry ticket prices are to be £3.50 in advance & £4.00 on the night.

Cllr's asked if the request made in 2019 (Minute 62/19) to use plastic free fireworks had been adopted, and if consideration had been given to a silent display or drone light show alternative or reducing the noise levels as several parishioners had previously said they find the noise distressing & some have conditions such as PTSD. Also is the RSPCA recommendation to limit the noise of fireworks to below 90db to reduce the impact for animals being followed?

It was noted the pollution and climate change impact required national action to have any significant effect and the contract for this year was already committed to, so no changes could be made without financial penalty. The Village Fund agreed to ensure any plastic or metal firework debris is cleaned up after the event.
